NEW UZBEKISTAN STRATEGY AND NEW CHANGES AND REFORMS  
IN UZBEKISTAN

The development strategy of the new Uzbekistan was defined as consisting of seven directions. This is not for nothing. After all, our ancestors considered the number seven to be a special symbol that brings happiness and good luck, and realizes good intentions.

With your permission, I would like to briefly touch on the most important tasks to be implemented within the framework of the Development Strategy.

First of all, our large-scale reforms aimed at establishing a people-friendly state, ensuring human dignity and his legitimate interests will rise to a new level through the development of a free civil society.

In this regard, we pay special attention to the implementation of the idea of "New Uzbekistan - a people-friendly and humane state", which serves to ensure the well-being of every citizen living in our country, regardless of nationality, language and religion. On this basis, we will further strengthen the role and responsibility of local government bodies in solving local problems. For this purpose, in the future, most of the state functions will be transferred from the center to the regions.

In order to connect the neighborhood system, which is the backbone of community management and directly reflects the results of the reforms, with hokims, the position of assistant mayor will be introduced in each neighborhood. The assistant mayor will be responsible for creating new jobs and reducing poverty. The chairman of the neighborhood is responsible for the implementation of spiritual and educational activities and the creation of a healthy environment in the family and neighborhood.

At the same time, there will be a representative of the Youth Affairs Agency, which regularly deals with youth issues in the neighborhoods.

In addition, in order to expand the financial capabilities of hokimities and neighborhoods, the district budget will be provided with additional resources, and a separate neighborhood fund will be formed.

Our next important task is to create a compact and efficient management system that serves citizens by transforming central offices. For this, first of all, the procedure for the establishment and termination of ministries and agencies, the criteria that distinguish them from each other, the specific requirements for determining the structural structure and staff will be developed. On this basis, the departments performing tasks in the same direction will be optimized.

We introduce new approaches to the process of work of central agencies with regional structures, abandoning outdated bureaucratic methods. At the same time,

the powers of ministries and agencies to quickly and independently solve socio-economic issues in the regions will be further expanded.

A reporting system for leaders will be established for the implementation of programs adopted for each branch and region.

At the same time, additional legal grounds will be created for People's Reception Rooms to literally become a structure that expresses the people's voice and public opinion.

At the same time, new, modern approaches to the selection and placement of personnel are introduced. Personnel are accepted into the civil service on the basis of selection, criteria for continuous training, performance evaluation and promotion are determined for them.

From now on, the activities of each region, sector and industry will be evaluated according to how the rights and legal interests of citizens are ensured in them.

In this regard, I would like to add to the call that "the people should serve our people, not the state bodies, and the state bodies should serve our people": "Leaders should serve not only the state, but first of all, the person and the family, to ensure their legitimate interests." Therefore, every official must know the life of the neighborhood and the district from thread to needle.

As our great ancestors said, the leader should not be a burden to the people, but on the contrary, he should take the burden of the people on his shoulders. If any leader does not understand this urgent demand of the times, neither our people nor life itself will accept them.

Senators and deputies, who are the people's representatives, play a particularly important role in the implementation of the development strategy of the new Uzbekistan.

Priority is given to the strengthening of parliamentary control aimed at further improving the activities of the Oliy Majlis, developing and implementing the legislative concept that our people are waiting for and serving to accelerate the development of New Uzbekistan, democratizing law-making activities and ensuring their implementation.

In this regard, the state of working with appeals for our country will be monitored by the parliament. The report of the heads of the local executive offices will be heard and, according to its results, effective measures will be taken against them.

Based on the experience of developed democratic countries, the system of society and state management must not depend on the subjective point of view of some leaders, in other words, their eyebrows, but on the contrary.
